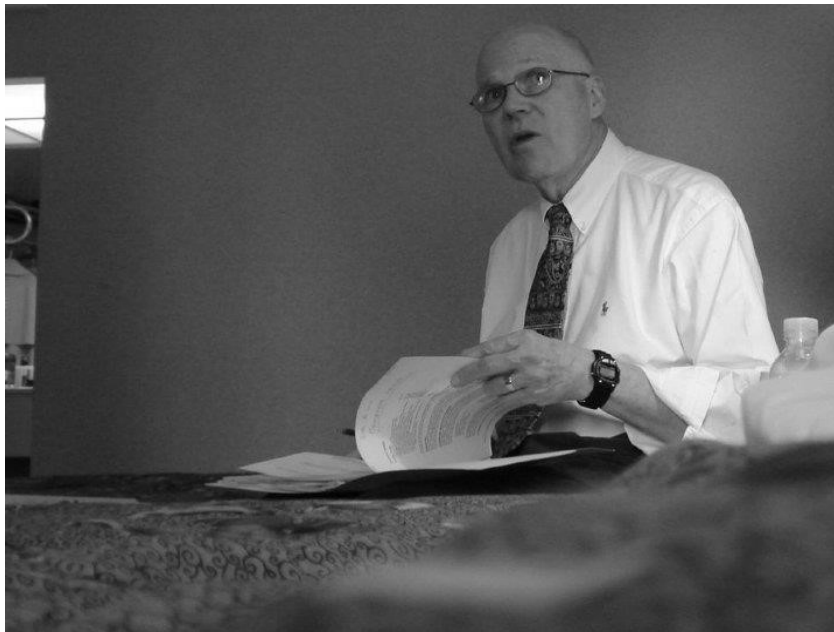

Parking on the SBU campus is free for our visitors and guests of our tournament. Visitor parking tags will be made available to you when you register. We recommend that you attempt to park behind the Jester Center (the same building as the library). Parking on Friday will be a bit tighter but there should still be plenty of spaces available. There will be ample parking available on Saturday.

### **SBU is a nonsmoking campus! Individual**

#### **Awards**

Awards will be presented to all students who reach elimination rounds of individual events, IPDA, and LD debate. Each member of the partnership in partnered events (e.g. Duo and IPDA) will receive a trophy.

We will recognize the top novice in each individual event.

**If the number of entries warrant, we will offer both novice and open divisions in IPDA. We define a novice as any competitor in his or her first year of collegiate competition.**

We will present quadrathon awards to the top three students. A student must be entered in at least 4 different events representing at least two of the three individual events genres (oral interpretation, platform speaking, limited preparation) to be eligible for quadrathon. **Only a student's top 4 events will count toward the quadrathon competition. Please note the "Interviewing" will not be counted towards the quadrathon.**

**We will also present a special award (the "Bright Young Scholar") to the top three students entered in both individual events and either IPDA or LD Debate. Please note that our schedule does permit LD debaters to cross over and compete in individual events!**

#### **Sweepstakes Awards & Formula**

We will present sweepstakes awards to the top three schools in debate, individual events, and overall. We will also recognize our top community college and our top participating Pi Kappa Delta chapter.

Sweepstakes points will be awarded to a school's top four performers per individual event. Schools participating in IPDA will earn sweepstakes points for their top four teams. In LD debate, two debaters will constitute one entry for sweepstakes purposes. In other words, a school can count its top eight LD debaters for sweepstakes purposes.

**Individual Events:** IPDA will present the following divisions- Novice and Open. Schools will earn sweepstakes points for a top three ranking in preliminary rounds...3 points-2 points-1 point for a 1, 2, or 3 rank respectively. Placement in final rounds will earn 6 points-5 points-4 points-3 points-2 points-1 point for places 1 through 6 or 7 respectively.

**IPDA:** IPDA will present the following divisions- Novice, JV, and Open. Novice division will follow the MAFA definition of 1<sup>st</sup> college year. This will allow a more assessable opportunity for students to join LD debate. Schools will earn 3 points per win in Lincoln Douglas and 0 points per loss in the preliminary rounds. Schools will earn 4 points per elimination round win and 2 points for an elimination round loss up until the final round. The final elimination round of IPDA will not count toward sweepstakes. **Lincoln Douglas:** LD will present the following divisions- Novice, JV, and Open. Novice division will follow the MAFA definition of 1<sup>st</sup> college year. This will allow a more assessable opportunity for students to join LD

debate. Schools will earn 3 points per win in Lincoln Douglas and 0 points per loss in the preliminary rounds. Schools will earn 4 points per elimination round win and 2 points for an elimination round loss up until the final round. The final elimination round of Lincoln Douglas will not count toward sweepstakes.

## Local Host Entries

Southwest Baptist University students (particularly our novices) may be entered in individual events and debate. SBU will not be eligible for sweepstakes awards.

## Fees and Judging Obligations

Fees will be calculated according to the following schedule...

---

Tournament Participation Fee IE entries: \$10.00 per student and judge either day IE

Entries: \$8 per slot

IPDA: \$25 per debater

LD: \$25 per debater

Uncovered IEs: \$10 in addition to the entry fee

Uncovered IPDA Debaters: \$50 in addition to the entry fee

Uncovered LD Debaters: \$50 in addition to the entry fee

Judging obligations....

In IPDA one judge will cover two IPDA debaters.

In Lincoln Douglas one judge will cover two LD debaters. In individual events one judge will cover six entries.

We will have several SBU and community judges available, but judges are a little scarce in Bolivar so please make every effort to cover your entries. **We'd rather have your judges than your \$\$\$.** For those paying with a check, please make it payable to SBU Forensics. **Please also note that we reserve the right to limit entries if needed. Schools with larger quantities of uncovered entries will be asked first.**

## Entry Deadlines and Instructions

You will receive a confirmation of your entry on Wednesday, September 25<sup>th</sup>. Fees will be assessed at that time.

## Individual Events Notes

### Individual Event Conflict Patterns

Pattern A: Extemp, Persuasion, DI, Poetry, Informative, Prose

## **Pattern B: Impromptu, POI, After Dinner, Communication Analysis, Duo, Interviewing**

### **General Rules**

AFA rules will be followed for all individual events. Students should not enter material that has been used in competition before September 1, 2019. The tournament will follow AFA tabulation procedures.

Extemp topics will cover issues pertinent to the socio-political realm with emphasis upon: international affairs, the 2024 elections, and the economy. Students will be able to have access to wireless on the campus (however we do not guarantee the speed of the wireless access). Extemp competitors may use the internet for prep.

Impromptu participants will choose between two topics that will vary by round and section. Topics will be drawn from philosophical quotations, song lyrics, and quotations from popular films.

Students may enter up to three events per conflict pattern. We will make every effort to place multiple-entered students who are entered in extemp in sections where they will draw as one of the first three speakers.

### **Interviewing**

Interviewing is designed to give students the opportunity to sharpen their questioning, job interviewing and resume writing skills. The event will consist of two rounds of interviews in pattern B of the preliminary rounds. Competitors should bring a copy of their resume to the preliminary rounds. Those students who break to finals will have their resumes evaluated based upon the presentation and professionalism of their resume and not their qualifications. As such, the final round in this event will be a “resume round” only—not a traditional final speech round.

Students will assume that they are applying for a generic summer internship in their field.

For preliminary rounds, competitors will be divided into sections of 5-6 competitors. A judge will interview each competitor for a maximum of 10 minutes using an interview protocol (instructions and list of generic interviewing questions) provided by the tournament. Judges will evaluate students on the interviewing performance and not whether they are a good fit for a specific job description.

**Competitors in this event MUST submit 1 copy of their resumes at registration. Failure to submit a resume will mean that a student is ineligible for the final round.**

**Although there is no novice division in individual events, we will recognize the top performing novice in each IE. We define a novice as a student in his or her first year of collegiate competition. At registration we will ask coaches to designate which of their competitors meets this definition.**

### **Lincoln Douglas Debate**

**In keeping with current practices in LD debate, we strongly encourage LD debaters to disclose their cases on the appropriate LD case list. We will send the link when it becomes available.**
